OLD BUSINESS

a. LAFCo – Attended the LAFCo meeting on November 8, 2023. This was the first meeting that the Cemetery District dissolution application was discussed. During the discussion, Supervisor Andersen stated that she was unaware of the District's financial issues and noted that her office made offers of a \$25,000 grant, starting a Alamo Cemetery Foundation which would receive donations for Alamo Cemetery care, and the use of her office – which she noted the District didn't take her up on any of her offers. The LAFCo commissioners had three options to vote on – 1. Vote to dissolve the District, 2. Vote to deny the dissolution and require budgets through the year 2029, and 3. Vote to continue the discussion while looking into other options including the possible consolidation of all Contra Costa County public cemeteries. The Commissioners approved option 3, with Supervisor Andersen demanding a financial study be performed.
